AUTHORIZATION- LETTER OF GUARANTEE

authorises EKLT OÜ, reg. no. 10036401, Custom agency's activity license no. TA/0035/EE100EE, to act on behalf of the authoriser (as declarant) as follows:

- 1) declare consignments received/sent to/from
and represent Authoriser in the Customs on any matters related to customs clearance of goods declared by EKLT OÜ, prepare and sign customs value declarations and pay the customs duties;
- 2) receive and declare accompanying documents and goods that arrived at other customs terminals;
- 3) if needed, open the consignments arrived to the name of the Authoriser via the EKLT OÜ customs terminal to check the conformance of the consignment content to the invoice;
- 4) submit requests for correcting and annulling the customs declarations;

The Authoriser bears full responsibility for the authenticity of oral and written data provided and confirms that the data on the accompanying documents are true and complete and in compliance with the goods. The Authoriser ensures timely submission of documents necessary for customs clearance (invoice, permission, license, certificate, etc) to EKLT OÜ.

In case the Authoriser violates the customs rules, it shall assume responsibility according to Chapter 13 of the Customs Act and other legislation of the Republic of Estonia.

According to the Law on Obligations Act § 628 section 2, the Authoriser also guarantees all tax and customs related payments to be made and transferred to EKLT OÜ bank account by the date indicated on the invoice sent by EKLT OÜ. In case credit is provided to the Authoriser to cover customs payments, the brokerage fee is added. The Authoriser guarantees to safekeep all customs clearance related documents as per the Community Customs Code §16 and the Taxation Act § 58, as well as provide these to EKLT OÜ withing 7 days at its request.

Authoriser's obligation to pay EKLT OÜ for its services and taxes is valid until sides of this guarantee complete their undertakings, even after expiration of this authorisation letter. If the Authoriser does not pay for the services and taxes on time then the delay fine of 0.5% per day from the total amount foreseen will be added to the payment.
